

THE RED RIVER VALLEY SCHOOL DIVISION
By-Law #1/26

BEING A BY-LAW of The Red River Valley School Division to establish the boundaries to the wards and the number of trustees in The Red River Valley School Division.

WHEREAS by virtue of Section 57(1), subject to Subsection (2), (3), (4), (5) and (6) of The Public Schools Act, being Chapter P. 250 of the Revised Statutes of Manitoba, the Board of Trustees of The Red River Valley School Division may pass a By-law to increase/decrease the number of wards and increase/decrease the number of trustees in The Red River Valley School Division.

AND WHEREAS the Board of Trustees of The Red River Valley School Division has determined that the ward boundaries for Ward I, Ward II, Ward III, Ward IV, Ward V, Ward VI and Ward VII established by By-law 2/10 are not representative of the needs of The Red River Valley School Division.

NOW THEREFORE the Board of Trustees of The Red River Valley School Division, duly assembled, enact as follows:

A TOTAL OF: 7 School trustees

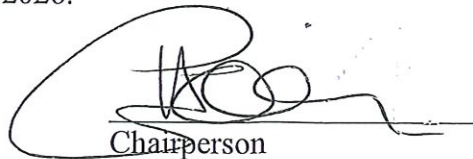
3. *THAT* election for trustees in the year 2026 and subsequent years be in accordance with the representation by wards as set out in this By-Law.
